Travel Activities and Sports Liability Waiver

1. Travel Liability

- a. It is understood that by the undersigned parent/guardian that their enrolled student athlete may from time to time travel to sporting events at different locations or various other activities. The undersigned agrees that The American Bilingual School will not be held liable for any mishap or accident that may result from the use of such transportation whether that transportation is professional limousine, taxi, bus or any other type of vehicle. Furthermore it is understood that The American Bilingual School will not be held liable for any mishap or accident that may occur after or before debarkation by professional or private carriers of passengers licensed or unlicensed.
- b. It is understood that payment will be made at the time of transportation via taxi, hired car or other form of transport The American Bilingual School is authorized to bill the undersigns account for travel expenses or the student is responsible for direct payment of these expenses.
- c. It is understood that the student athlete will conduct himself/herself in a respectable manner while on the bus. This includes sitting at all times that the bus is moving and behaving in a way that is not detrimental to the driver's ability to focus on his job. If a student isn't able to conduct himself/herself in an acceptable manner he/she will not be allowed to use school provided transportation to the various venues and must provide his/her own transportation. Additionally it is understood that any damages incurred to the transportation due to student's behavior will result in the in the parents be charged for the damages.
- d. I have read the above written understanding of Travel Liability and therefore I sign below in agreement with the provisions stated.

2. Release of Liability

I _____ (name of parent or guardian) hereby acknowledge that my son/daughter, _____ has voluntarily applied to participate in the athletic program or activities offered by The American Bilingual School. (ABS)

I am aware for athletic participation and some activities are inherently dangerous activities. My son/daughter is voluntarily participating in these activities with my full permission. I hereby agree to accept any and all risks of injury or death to my son/daughter associated with his/her participation in the athletic program offered by ABS.

As lawful consideration for my son/daughter being permitted by ABS to participate in ABS's athletic program, activities programs and use ABS's facilities. I hereby agree that I, my heirs, distributes, guardians, legal representatives and assigns will not make a claim against, sue, attach the property of, or prosecute ABS and/or any of its affiliated organizations for injury or damage resulting from the negligence or other acts however caused, by any employee, agent or contractor of ABS or its affiliates as a result of my sons/daughters participation in ABS's athletic/activities programs. In addition, I hereby release and discharge ABS and it affiliated organizations from all actions, claims or demand, I, my heirs, assigns, distributes, guardians, legal representatives now have or may hereafter have for injury or damage resulting from the participation of my son in the ABS athletic/activities programs.

I certify that my son has no known physical or mental condition that would impair his/her ability to fully participate in ABS's athletic/activities program.

I have read this agreement and fully understand its contents. I am aware that this is a release of liability and a contract between me and The American Bilingual School and or its affiliated organizations, and I have signed it of my own free will.
